irector's Report - 2018

Dr. Alexius Ekka, S.J. Director, XISS

The academic year 2017-2018 commenced on 17th June 2017 with Dr. Jerome Joseph, Professor Indian Institute of Management, Ahmedabad as the Chief Guest. In his keynote address he said that the Management Education in a Jesuit B-School was a privilege and so all those who studied at XISS must make the best of the opportunity. The professional education at XISS was as good as it was at the IIMs all over the country. Soon after the inaugural function the orientation cum induction programme of the new students began in the respective streams. This annual report consists of five sections: (1) Farewell and Welcome to the Institute's Faculty, Project Officers and Staff, (2) Governance and Administration, (3) Departmental Reports, (4) XISS & International Associations and (5) The Tasks Ahead.

I. Farewell & Welcome

The Institute expressed deep gratitude to the superannuating employees during the academic year 2017-2018. The first in the line was Mr. Syed Reyaz Irfan of the Department of Research and Planning. He gave his valuable services to the Institute for 28 years. The Institute bade him farewell on 13th May 2017. Second in the line was Prof. H.K. Singh, the Librarian. He served the Institute for 34 years. The Institute wished him well on 21st December 2017. Next was Mr. Pratul Chandra, also from the Department of Research and Planning. He served the Institute for 29 years. The Institute gave him farewell on 5th March 2018. And finally Dr. (Prof.) M.H. Ansari, the HOD of the Department of Rural Management retired after 36 years of service to the Institute on 27th March 2018. But on account of his request and the need of the Institute he has been re-employed on contract basis for a year.

Other Professors and Staff of XISS who left the Institute on their own were Dr. Joe Kelvin Walter Hill in May 2017, Prof. Subhajit Bhattacharya in July 2017, Prof. Sanjeev Bajaj in August 2017 and Mr. Francis Xavier Tirkey in December 2017. The Institute is also grateful to each of them for their committed services in their respective Departments.

The Institute also welcomed the following Faculty and Staff who joined various Departments since 2017. They were Prof. Pooja

II. Governance and Administration

The Institute came out with the 5th Edition of the Personnel Rules with effect from April 2018. Prior to that there was consultation with the Faculty and Staff on its draft. The New Personnel Rules also give a brief history of XISS and spell out the vision and mission of the Institute along with the Characteristics of Jesuit Education. It has been drafted as per the 7th Pay Scale structure and the latest guidelines of the AICTE.

Another significant development in the Institute has been the starting of the Departmental Leadership in rotation as per the recommendation of the Governing Body of XISS. The appointment of the new incumbent will be for four years on the basis of seniority, experience, ability of governance and administration and willingness to discharge the duties and responsibilities. Consequently, the change of guard for the six Departments was announced on 28th March 2018 to be effective from 17th June 2018 at the starting of the new academic



year. But first of all the Director thanked the outgoing HODs for their committed and innovative leadership in a public function at XISS. They were: Dr. M.H. Ansari of the Department of Rural Management, Dr. Himadri Sinha of the Department of Research and Planning, Prof. S.R. Shauq of the Department of Human Resource Management, Dr. S.N. Singh of the Department of Information Technology, Prof. A.R. Bodra of the Department of Marketing Management and Dr. Ratnesh Chaturvedi of the Department of Finance Management. The new HODs appointed were Dr. Himadri Sinha for the Department of Rural Management, Dr. R.K. Agrawal for the Department of Human Resource Management, Dr. Mahua Banerjee for the Department of Information Technology, Dr. Pinaki Ghosh for the Department of Marketing Management, Dr. Arup Mukherjee for the Department of Finance Management and Dr. Pramil K. Panda for the Department of Research and Planning. In a moving function of felicitation the outgoing HODs thanked their respective Departmental colleagues for their whole hearted collaboration and wished their incumbents all success in their leadership. The Newly Appointed HODs thanked their predecessors for their landmark achievements and the examples of camaraderie set by them. Dr. Himadri Sinha took over as the new HOD of the Department of Rural Management on 3rd April 2018 and the rest would do so as the new Academic Year begins in mid June 2018.

III. The Departmental Reports

1. Human Resource Management

During the induction the first year students benefited from a session by Mr. Rakesh Tigga, HR Head of Hindalco Muri on "Expectations of the corporate world from young HR Professionals"; and by Mr. Pramod Kumar, HR/ IR Head, Tata Motors on "Challenges of the HR profession". The field works for students in 7 centres in Ranchi city for the poor and the Differently Abled inmates of various organizations have continued with teaching, counselling, tree plantation drive and health awareness programmes. The Retreat and Rural Visits of the first year students at the Society for Rural Industrialization (SRI), Bariatu was also remarkable under the leadership and guidance of Dr. Shyamal Gomes. Similarly their industrial visits to the nearby industries under the care of Prof. S.R. Shauq and Dr. M. Spring and industrial tours for the second year students at Delhi and Kolkata were very enriching. The students further participated in the HR Analytics Conclave at MDP SAIL organized by NHRDN, IIM-Ranchi, XISS and SAIL, Ranchi from 11-13 Nov. 2017. They later attended an HR-IR Conclave organized by CII – Jamshedpur Chapter. And finally Ms. Riya Ray, a second year student participated in the 5th Awanish Kumar Dev Memorial Lecture on 30th August 2017 at Hyderabad organized by Maruti-Suzuki XISS Awanish Kumar Dev Trust. 2. Rural Management

This year in the first year Rural Management there is a good gender balance among the students. The rigours of writing the term papers and doing the Summer Internship Projects have made the first and the second year students respectively more professional. Similarly, the study tours for the second year students in groups of 25 to the northern, southern and western regions of the country were insightful and motivating. The first year students have been duly engaged in *Thematic Field Work* in different groups in 10 slum centres of Ranchi for field work. In groups of 25 they had also fruitful Institutional Visits to AKSW, Khunti; JSLPS, Nagri and ISSNIP, Khunti on 18th August and to AROUSE, Gumla; LEAD, Khunti and PRADAN, Torpa on 21st August 2017. In the international scenario Ms Eliza Chakraborty, Mr Rajender Bisht and Ms Ankita Toppo participated in the summer course on *Europe: Diversity and Migration* at Stads campus, University of Antwerp, Belgium from 26th June to 7th July 2017. This year Ms. Kanaya Mahanti and Mr. Debdorshi are selected for the USOS scholarship to attend the summer school on the same topic at the University of Antwerp from 25 June to 6 July 2018. The

Department as a whole conducted a CSR *Choupal* in collaboration with TSRDS, Jamshedpur on 29th October 2017 and a consultative meet on *Save the Children* with UNICEF, Ranchi on 17th Nov. 2017. As regards the Faculty engagement in seminars and trainings following were significant: Prof. M.H. Ansari conducted two sessions on "Promoting Critical Thinking in College" organized by Ranchi University Academy of Staff Training, Ranchi on 28th June 2017 and Dr. Raj Shree Verma Presented a paper entitled "Social Justice among Women through Literacy Leads to Sustainable Action: An Understanding" at 23rd World Forum of IAJBS held at the University of Namur, Belgium from 16-20 July 2017. 3. Information Technology

It is heartening to note that on account of the Departmental efforts to popularize the course in the under graduate colleges of Ranchi, the total intake of students has been 60 in the academic year 2017-2018 as allowed by AICTE. The newly admitted students had a two-day memorable orientation and induction programme soon after the inauguration of the academic year. Later during the year the students participated in the debate competition on the topic "My Vision Corruption Free India" organized by FCI on 28th Oct. 2017 at XISS as part of Vigilance Awareness Week. The second year students participated in a workshop on "Digital Marketing" held at XISS on 6th Nov. 2017. Along with Dr. S.N. Singh, and Mr. Himanshu S. Mahanta, the students also participated in the National Seminar on "Cyber Security: Emerging Trends" held at ICFAI University, Ranchi. Prof. Rik Das co-authored an article entitled "Partition Selection with Sparse Auto Encoders for Content Based Image Classification, Neutral Computing and Application" (2017) in *Springer, I.F.:2.505, (Thomson Retuers JCR (latest report),* DOI: 10.1007/s00521-017-3099-0, Springer Verlag. Dr. Madhumita Singha presented a paper on "Sustainable Agriculture: Case Study of CSR Intervention of XISS and HPCL in Mukunda village of Jharkhand" at 23rd World Forum of IAJBS at the University of Namur, Belgium during 16-20 July 2017.

4. Marketing Management

Three new Faculty Members were selected in the Department recently. They are: Mr Bhabani Mahapatra (Asst. Professor) for Quantitative Economics/Economics and Research Methodology, Ms Pooja Mishra (Asst. Professor) for Organizational Behaviour, Human Resource Management and Business Ethics and Ms. Tina Murarka (Asst. Professor) for Finance & Accounts and Business Law. Four second year students participated in the 4th Annual Students' Conclave "SANGATI" on September 2017 organized by KIIT School of Rural Management. Mr. Frank Russel and MR. Rohit Banerjee won the first prize in the debate – "Fortune at the Bottom of Pyramid by Dr. CK Prahlad: Theory or Practice". Mr. Amar Kumar Singh and Ms. Richa Abhilasha won the consolation prize in the development of an – "Innovative Rural Marketing Model for Rural Development". Two students – Mr. Pranjal Pragya and Mr. Saurabh Agrawal participated in a seminar – "Road to GES" on the theme *Fostering Innovation and Entrepreneurship among Academic Institutions*, organized by the Department of IT & e-Gov. Government of Jharkhand in association with National Research Development Corporation (NRDC), New Delhi on 22nd Nov. 2017 at Hotel BNR, Chanakya, Ranchi. The second year students went for the Industrial Visit from 6th to 16th Oct. 2017 to Delhi, Mumbai and Kolkata accompanied by the Faculty Members. And finally three new courses have been introduced in the Department: Business Analytics, Econometrics, and Sustainable Business Models, keeping in mind the requirement of the Industry.

5. Finance Management

The Department of Finance Management also has three new Faculty Members since this academic year. They are Dr. Amit Kumar Giri, Asst. Professor for Economics and Statistics; Dr. Rishi Dwivedi, Asst. Professor for Operation Research and Logistics and Supply Chain Management and Dr. Jay Prakash Verma, Asst. Professor for Marketing. With the new incumbents the Department is doing better in academics and co-curricular activities. Apart from the usual Freshers' welcome at the start of the academic year and the rural exposure visits and industrial visits the Department has very uniquely started FinaXiss, a Finance Club of XISS. Its primary objective is to create a challenging environment among the budding professionals and help them understand different Business phenomena. Among the Faculty members Dr. Amit K. Giri has been one of the 20 recipients of the prestigious Regulating Descent Work (RDW) fellowship from the International Labour Organization (ILO) for the year 2017. He also received US \$ 1000/- for his research wok and was invited by ILO at Geneva to present his work at the 5th Regulating for Decent Work Conference during 3-5 July 2017. His paper was "Labour Conditions in the Global Value Chains in India: the Case of Hand-Knotted Carpet Manufacturing Cluster". Dr. Rishi Dwivedi has jointly developed a performance measurement tool for an agricultural enterprise using balanced scorecard and quality function deployment models. Fr. Pradeep Kerketta, SJ, Asst. Director and Dr. Amit K. Giri presented a research project entitled "Working Conditions of Daily Wage Labourers in Ranchi, Jharkhand" at the Indian Society of Labour Economics (ISLE), Trivandrum, Kerala during 16-18 December 2017. Dr. Bhaskar Bhowani presented a paper at IAJBS 23rd World Forum from 16-20 July 2017 entitled "Creating Sustainable Entrepreneurship through Microfinance Initiatives: A Case of Jharkhand, India". Dr. Ratnesh Chaturvedi, Dr. Bhaskar Bhowani and Dr. Jay Prakash Verma took sessions at the two-week Faculty Development Programme for participants from various states organized by the Department of EDP of XISS from 20th Nov. to 2nd December 2017.

6. Department of Research and Planning

During 2017-18, the Department has completed 16 research projects. It has applied for 51 new projects out of which around 11 or 12 new projects are likely to be awarded to XISS shortly. Among the new projects, most noteworthy one is a national level study on Social Inclusion of SC and ST in NDP I (National Dairy Programme Phase I). This programme is funded jointly by Govt. of India and World Bank. This study will be conducted in 10 states across India under the aegis of NDDB, Anand. In July 2017, the Department has submitted its recommendation on restructuring of DRDA under the Department of Rural Development, Government of Jharkhand. The XISS Research Department has suggested practical ways of making both DRDA and Department of Rural Development to be more effective and accountable. It is now up to Government of Jharkhand government to implement the same.

Dr. Himadri Sinha has been invited by Prof. Dr. Clare Lyonette from the Institute for Employment Research (IER), University of Warwick, UK to collaborate as Co researcher in the Project titled **GCRF Skills and Education 2018**. Prof. Sinha and XISS have sent their consent for the same to complete the international registration process. The Project will commence shortly.

Dr. Himadri Sinha was invited as an Expert Member of 1st Common Review Mission of Ministry of Panchayati Raj Institutions, Govt. of India to examine the progress and impact Fourteenth Finance Commission's grants (FFC grants) given Gram Panchayat directly. CRM was held during August and September 2017.

The 5th batch of trainees is currently undergoing the Short Training on GIS and Remote Sensing. The training prepared the trainees as job ready. Nearly all the trainees are recruited during training period by various companies. So far this training has recorded near 97% placement.

Dr. Pramil K. Panda delivered a lecture on 'Beyond the Etiquette: Parenting a Child with Autism' in the weekly seminar organized by the Rotary Club at Ranchi Club Complex, Ranchi on 21 September, 2017. Dr Amardip Singh presented a paper 'Isolation, Characterisation and Classification of Plant Growth Supporting Bacteria'



in the International Conference on Advances in Environmental & Agricultural Biotechnology (ICAEA-2018), held on 22-24 February 2018 at St. Xavier College, Ranchi, Jharkhand. Dr. Pramil K. Panda published a paper in renowned Economic and Political Weekly journal

7. Department of Research and Publication

The Jharkhand Journal of Development and Management Studies (JJDMS) has been enlisted in the UGC approved list of journals where the Professors and Teachers are accepted to publish their papers for consideration for the purpose of Career Advancement Scheme (CAS) and Direct Recruitment of Teachers and other Academic Staff as required under UGC. Fr. Alex Ekka, SJ, Director, presented a paper at the 23rd World Forum of IAJBS at the University of Namur, Belgium during 16-20 July 2017 on the topic: "Sustainability and Social Justice: A Case or Organic Farming in India". He also led the XISS delegation of three Executive Members of the Institute's Alumni Association (AAXISS) to the 9th Congress of World Union of Jesuit Alumni (WUJA) held at John Carroll University, Cleveland, Ohio in USA from 28th June to 2nd July 2017. Dr. Sudeep Kumar published an article on "Promoting human behaviour for environmental sustainability: An urgent need for homeostasis of the society" in *Delhi Psychiatry Journal, 20*(1), 18-22. Fr. Alex Ekka, SJ co-authored and published the book *Securing Childhood Challenges, Opportunities and Strategies*, Ranchi: Xavier Institute of Social Service (ISBN: 81-904112-0-9), 2017. Secondly, Fr. Alex Ekka, SJ and Dr. Sudeep Kumar published the combined volume of *Jharkhand Journal of Development and Management Studies* (with index, Vol. 14), Ranchi: Xavier Institute of Social Service, Ranchi, 2017.

8. Central Placement Cell

First of all the Central Placement Cell (CPC) prepared the Placement Brochure – 2018 by 23rd September 2017 and sent the copies to 183 organizations. The CPC also compiled the questions asked during the interview and the GD topics and provided them to the current second year students for mock interviews and GDs. Based on the summer internships 5 Pre-Placement Offers have been received – 3 for HRM and one each for RM and Marketing Departments. Till today Department wise following is the campus placement scenario: HRM = 50/73, RM = 68/73, MKT = 49/52, FIN = 50/52 and IT = 18/35. According to Business India the ranking of XISS is 52 among all the PGDM Institutes in the country as reported on 30th Nov. 2017. The highest salary package is Rs. 13.50 lakhs and the average salary package Rs. 5.87 lakh per annum. Overall 82.7% students have been placed as of now.

9. Library and Documentation

With the coming of Mrs. Samidha Lakra, Assistant Librarian, the Department of Library and Documentation has geared up to provide better services through print and digital forms. The library has a collection of 36,000 books in all the disciplines of management education at XISS. Similarly it has 82 periodicals from India and abroad having 3275 accumulated back volumes of bound journals. The library has also all the issues including back issues of the Institute's Quarterly *Jharkhand Journal of Development and Management Studies* (JJDMS) both in loose and combined volumes. Then apart from the topic wise paper clippings, the Institute has the facilities of e-Library of EBSCO online database and EBSCO HOST Business Source Elite.

10. Entrepreneurship Development Programme

The Entrepreneurship Development Programme of the Institute carried out five Entrepreneurship Awareness Camps (EAC) one each at (1) Al-Kabir Polytechnic, Jamshedpur, (2) Government Women's Polytechnic, Jamshedpur, (3) Xavier Institute of Polytechnic and Technology (XIPT), Namkum, (4) Government Women's Polytechnic, Ranchi and (5) Government Polytechnic, Ranchi from August to November 2017. The EDP also conducted two Faculty Development Programmes on Entrepreneurship at XISS for outstation participants of various Colleges and NGOs from September to December 2017. From October 2017 to January 2018 the Department of EDP also conducted the first batch of skill training on Computer Hardware for the unemployed Scheduled Tribe Youths of Jharkhand. And finally, on the occasion of "National Education Day", 11th November

2017, Mr. Harpreet Singh Ahluwalia and Mr. Arif Hussain attended a workshop at the Government Polytechnic, Koderma and delivered a talk on the "Need and Importance of Entrepreneurship at the Present Scenario".

11. Development Resource Centre

There have been two main projects during the present academic year. The first one is the Enhancement of Livelihood Opportunities in the selected Blocks of the south region of Chotanagpur in Jharkhand. There are 11 Voluntary Organizations working along in this project for the capacity building of Community Based Organizations (CBOs) through Self-Help-Groups (SHGs). A total of 1377 target groups are engaged in income generation activities through the VOs and CBOs in poultry farming, vegetable cultivation, lac cultivation besides pig and goat rearing and small scale shop keeping in the rural areas.

The second one is India Development Gateway Initiatives (InDG) Vikaspedia. It is supported by the Department of Electronics and Information Technology (DIETY) under the Ministry of Communications and Information Technology. The project is monitored by C-DAC, Hyderabad.

12. Childline Outreach Programme

An agreement between XISS and CIF (Childline India Foundation) was signed on 4th July 2017 for another three years. The grant of the previous financial year 2016-2017 was sanctioned on 13th Nov. 2017. Childline stands for a friendly Didi or a sympathetic Bhaiya who is always there for vulnerable children 24 hours of the day and 365 days a year. Childline Ranchi is the urban model of 1098 free telephone service and is delivering the service through three partner organizations in Ranchi District. First in this is Xavier Institute of Social Service (XISS), Ranchi, which is a Nodal Agency. Its coverage area is Ranchi City. Second is the National Domestic Workers Welfare Trust, a Collaborative Organization. Its coverage area consists of 35 Municipal Wards (1-36 except 29) of Ranchi Municipal Corporation and Namkum Block. And the third is *Chotanagpur Sanskritic Sangh* covering the 21 Municipal Wards (37-57 and 29) of Ranchi Municipal Corporation. Additionally a CHILDLINE unit is operational at Ranchi Railway Station since 2015 coordinated by one Br. Maju Mathew.

In the year 2017-2018 the number of cases intervened and rescued by Railway CHILDLINE is: lost / abandoned child – 14, runaway children – 66, assisted by children – 3, begging – 1 and possibly trafficked – 67. Similarly, during this year CHILDLINE Ranchi conducted 24 Open House Programmes. It is a platform for children to express their opinions, give suggestions, address conflicts and give feedback. CHILDLINE Ranchi has also ensured participation of Principals, School Teachers, Students, Ward Members, SHG members, and other stakeholders in these programmes.

CHILDLINE team has conducted a total number of 46 person hours of outreach and awareness programmes in the financial year 2017-18. Out of 469 cases, 207 cases have been received from outreach and awareness programme. Under this outreach programme a special event called *Childline se Dosti*, a weeklong campaign was organized from14-20 Nov. 2017. XISS feels proud to have very committed Professionals like Mr. Sanjay Verma, Programme Director and Ms. Suradha Kachchap, the City Coordinator doing such a commendable work in CHILDLINE Ranchi.

IV. XISS & International Associations

The Alumni Association of Xavier Institute of Social Service (AAXISS) was represented at the 9th World Congress of World Union of Jesuit Alumni (WUJA) at John Carroll University, Cleveland, Ohio, USA from 28th June to 2nd July 2017. The AAXISS delegation consisted of Fr. Alex Ekka, SJ, President; Mr. Alok Kumar, Secretary; Dr. Pinaki Ghosh and Dr. Amar E. Tigga, both Executive Board Members.. A total of 9 delegates from Ranchi Province and 40 from other Provinces in India were present among the 120 delegates from all over the world. It was a learning experience for the AAXISS delegates about the Vision and Mission of WUJA, which was reflected in theme of the Congress – "Uniting Jesuit Frontiers". It meant taking up more challenging tasks to bring about



justice, peace, equality and dignity in the society all over the world. During the trip to USA, the AAXISS delegates re-established the contacts with Prof. James Stoner and Prof. Frank Werner at Fordham University, New York.

The second international presence of XISS was at the 23rd World Forum of International Association of Jesuit Business Schools (IAJBS) held at the University of Namur, Belgium from 15-19 July 2019. The four persons presented papers on the theme of Sustainability and Justice were: Fr. Alex Ekka, SJ, Director, Dr. Raj Shree Verma, Dr. Madhumita Singha and Dr. Bhaskar Bhowani. Fr. Alex continues to be a Board member of IAJBS.

V. The Tasks Ahead

XISS has stepped into the post Diamond Jubilee era and during this time an overhauling and restructuring of its vision-mission, goals and objectives as well as teaching – learning styles is envisaged. Consequently, first in the agenda is a Three-Day Workshop for all the Faculty Members and Project Officers on the theme: *"Revisiting and Reconfirming the Vision-Mission of XISS"*. This is scheduled to be held from 10-12 May 2018. A similar but short programme will also be organized for the staff members of the Institute soon thereafter.

The second task to be accomplished is to gain momentum in actualizing the University Status to XISS. A total of 35 acres of land has been obtained for this purpose in the campus of Agricultural Training Centre (ATC), Namkum along the Ranchi – Tatanagar Highway. Proper clearance of the ownership of the property is in the offing along with the construction of its boundary wall. In the meantime a master plan for the proposed XISS University is in the making along with its Vision 2020. Working towards actualizing the XISS University will be a priority in the coming years.

A Word of Thanks

At the end I would like to thank all the Faculty Members, Project Officers and Staff Members for their total support in running the Institute, which is not only a B-School but also an organization for social involvement particularly with the disadvantaged groups both in the rural and urban areas. I also thank you all for being Jesuit collaborators in imparting excellent management education and bringing about peace, justice and reconciliation in society through intellectual activism as well as through grassroots involvement from time to time.

XISS is also grateful to its alumni association both at the centre and at the different Chapters in Delhi, Mumbai, Kolkata, Bangalore, Patna, Pune and other places in the country as well as abroad. The XISS Alumni anywhere are the Institute's brand ambassadors. We count on their association with their alma mater for mutual enrichment.

And finally, I would like to wish all success and bright future to all the graduating students. XISS was glad to have you all these two years when each one of you proved to be a unique leader and a man or a woman for and with others. Remember the motto of the Institute *"Leaven in the Dough"* and continue to transform the society from within just as the maxim signifies. Thank you and God bless you.

The Department of HRM organized a two-day training program for the HRM-I & HRM-II students on Labor Laws and IR. The program was conducted by the eminent scholar of Labour Laws and IR, Prof. P. K. Padhi of XLRI Jamshedpur. The program was conducted in the second week of December 2017.

6. Social Service Field Work (SSFW)

The Social Service field work continues in 7 centres across Ranchi city. The students are engaged in teaching, organizing competitions, plantation drives and health awareness programs. The 71st Independence Day was celebrated with high spirits and fervour throughout all the fieldwork centres. Prof. Shyamal Gomes with the help of Mr. Binod Thakur and others organized a joyful learning methodology workshop on the 26th of August 2017. Prof. Ms. Indrani Ghatak has started to assist Prof. Gomes in his endeavours of conducting Social service field work.

The students of 2017-19 batch were very active and took great initiative in their social service fieldwork under the guidance of Prof. Dr. Shyamal Gomes. Like every year the entire class (74 students) was divided in 7 groups to attend 7 Centres – St. Xavier's School Doranda - Outreach Programme, Cheshire Home Bariatu, Guru Nanak Home for the disabled, Bariatu, MMK High School, Bariatu for the minorities, Brajkishore Netraheen Balika Vidyala, Bariatu, St. Michaels School for the Blind, Bahubazar, Indradhanus Project, and Government Girls Middle School, Hindpiri. The main objective is to socially engage the budding managers and groom them as true human beings besides their professional attitude in the field of Human Resource Management. The schedule had each student spending more than two hours thrice a week at these centres to help the inmates / young kids with their studies and encourage in improving their hidden talents through extracurricular activities. Besides, the scheduled activities in different social work centres this year, the students also participated in a number of outreach programmes like organising the street plays on Tobacco use and ill health, Sanitation, Girl Child Education, and the historical as well as environmental issues, in different centres with the students / inmates. They also continuously monitored *Swachh Bharat programme* in different centres, which was initiated by their seniors in the last year.

Moreover, the students took initiatives for Plantation, Health and Hygiene week celebration and crafts development week celebration in various centres. The team members for St. Xavier's Doranda, organised a sports competition on 26th January 2018 and felicitated the most clean household as well as the girl student with 100% attendance in the Dibdih village like previous year. They also conducted a talent survey for initiation of future activities of education in Dibdih Village. Team Brajkishore took very important initiative by organising a special program at Governor House on 20th January 2018.

6.1 Workshop on Joyful Learning

Prof. (Dr.) Shyamal Gomes organised a two-day workshop on *'Joyful Learning Methodologies'* at XISS on 26th August and 18th November 2017, for the first year Human Resource Management students. Fr. Pradeep Kerkatta, S.J. (Assistant Director, XISS) was the Chief Guest. The main speaker of this workshop was Mr. Binod Thakur from Greater Ranchi Development and Action, Government of Jharkhand. The main objective was to orient the management students about joyful teaching cum learning methodologies, so that they can learn and practice how to handle the learning sessions; engage in a friendly manner with weaker students and also share with teachers for good teaching; learn dynamics of motivation and how to engage the work/trainee/ student force for greater participation.





The major objectives of this workshop were

- 1. To learn the joyful methods of sharing.
- 2. To help the children develop their cognitive and non-cognitive skills.
- 3. To improve our presence at the centre by more involvement rather than engagement only.
- 4. To develop creativity and intelligence among the budding managers.

6.2 Plantation / Kitchen Garden Drive

In order to develop teamwork amongst the inmates / staff, awareness towards organic farming, climate change, etc. the following fieldwork centres continued the kitchen garden drive from June - November 2017.

Cheshire Home: In the third week of August 2017, a one-day kitchen gardening activity was carried out by the team members and children of the centre. Flowers and vegetables like marigold and Papaya were planted in

the garden of the centre. Students and residents of Cheshire home actively participated in the plantation of saplings and shrubs and celebrated nature in a manner as If they established a communion not just amongst themselves but also with the nature.

St Michael's School for the Blind: The objective of this kitchen garden activity was to provide vegetables to the centre for consumption. It aimed at utilizing the idle resources present at the centre and ensure that the students realize the relevance of environmental sustainability. Papaya, mango, pomegranate, lemon, chili, groundnuts, ect. were planted at the centre and the group members as well as the students of the centre religiously took turn to water the plants every alternate day.

Guru Nanak Home: The kitchen garden activity here was a two-day event. On the first day. The soil was tilled and prepared for gardening, and on the second day, vegetables like papaya, brinjal, coriander, pumpkin, and spinach were sown. The team members and the children of the centre regularly took turns to water the plants.

6.3 71st Independence Day Celebration at Field work Centres

Like every year, all the centres of SSFW celebrated Independence Day in their own unique way. There was celebration in the air and everyone took pride to be an Indian. All the kids in the various centres were soaked in the spirit of brotherhood and nationality. The Chief Guest at various centres first of all hoisted the national

The Department of Human Resource Management organized the 'Felicitation Ceremony' at XISS on 6th April 2018 during the farewell ceremony at XISS. Dr. (Fr.) Alexius Ekka, S.J. thanked all the centre heads for extending their cooperation and support to the students of HRM. The Assistant Director of XISS and the Superior of XISS distributed the achievement certificates to the outgoing students (Diploma Graduates), on their outstanding performance in the Social Service Field Work.

7. Retreat and Rural Visits

This year also Xavier Institute of Social Service engaged the students of Human Resource Department in Retreat cum Rural exposure for four days which was organized at the Society for Rural Industrialization (SRI), Bariatu and its operational villages (Rural Technology Park) at Angara block of Ranchi. Retreat & Rural Exposure means taking a step back from your day to day activities and serve the society and the nature to which we

Under retreat there were five sub components like Meditation & Prayers, SEVA (Self Evolvement & Voluntary Actions), Social Inputs by experts, Rock climbing & other Team Building Exercises and Cultural activities.

In the Rural Exposure the main activities were Group wise *Tollah* (hamlet) visits, interactions with the villagers, SHG members, rural entrepreneurs and community leaders, and *shramdan* and awareness building through *nukkad natak*. It was an opportunity for the students to interact with the village leaders and empowered women in different villages of Angara block of Ranchi district. The students of HR enjoyed this camp as an eye opener and they felicitated the organizational heads, villagers, social activists and others by proposing the vote of thanks and presenting the XISS mementos as their token of gratitude. The entire Retreat and the Rural Exposure was full of excitement and participatory activities.

Integrated Farming - Fisheries, piggeries, goataries duckeries, horticulture, agriculture, etc

This year also whole group visited the Integrated Farm house in a small village in Angara, where the family of Mr. Ujyas Toppo lives and sustains itself through agriculture, fisheries and poultry etc. In 2010, Mr. Toppo received the President's award for his integrated farming and fisheries. His family consists of his wife Mrs. Swita Toppo, his son and daughter. He and his brother hold a total of 80 acres of land. They have their own cattle as well as pig house and grow plants like lemon, mango, and banana. Electricity is provided by government and various aids are given to them. They have a total income of around Rs. 2-3 lakhs p.a. and have maintained a decent living.

Games and Meditation: In the evening it was the time to relax and rejuvenate through games and meditation. Students played various games under the guidance of Prof. Dr. Shyamal Gomes. These taught them team work and coordination and the importance of proper communication. In the evening prayers and meditation of different religions through a variety of practices were organized to promote relaxation, build internal energy and develop compassion, love, patience, generosity and forgiveness. They also learnt the importance of meditation and prayer in life. After the Meditation & prayer, some documentary films like 'Aaj Ka Bharat', etc. were shown to them so that they could relate with the urban and rural India. It basically highlighted various aspects of Incredible India featuring its culture and diversity. It also focused on the emerging problems like deforestation, child labor, police brutality, poverty, environmental pollution, unemployment and most importantly women rights. After watching this documentary students expressed their views and concluded that it was high time to bring about a change in the existing situation of the nation.

Department of Rural Management

Prof. (Dr.) M.H. Ansari Head of the Department

1. Genesis of the Department

The Post Graduate Course in Rural Management (PGDM-RM) of Xavier Institute of Social Service was started in 1975 by the then Director Fr. M.V.D Bogaert, S.J. Today it is recognized as the flagship course of the institute. The course has now completed 43 years of excellence in creating rural management professionals. Our Alumni are working in various sectors i.e. Government, PSUs, Corporate, Funding Agencies, International NGOs and Banking Organisations in India and abroad.

2. New admission

A total Seventy-Five students with almost equal gender proportion from various academic disciplines like Agriculture, Engineering, Humanities, Social Science, Commerce, and Computer Science were admitted in the PGDM- Rural Management course for the academic year 2017-2019. Like previous years, the enrolment of this year was also a geographically balanced as some of them belong to the states of Rajasthan, Gujarat, Uttarakhand, Uttar Pradesh, Madhya Pradesh, Delhi, Odisha, West Bengal, Bihar, and Andhra Pradesh.

3. Class Room Learning

The 43rd academic session of PGDM-Rural Management was inaugurated on 18th of June 2017 with a 3-day Induction-cum-Orientation programme. A team of faculty members of this Department under the leadership of Prof. (Dr.) M. H. Ansari introduced to the students, the two-year course structure, curriculum of the syllabus, pedagogy of teaching, examination patterns, activities beyond academics and rules and regulations of the Institute. A group of Alumni working in the Industries, NGOs, and Government sectors was also invited to enlighten the new entrants. The scheduled classes of 1st and 2nd-year students started from 22nd of June 2017. The 2nd year students of Rural Management were also offered six elective papers in the beginning of their 4th Trimester namely GIS & Remote Sensing, RCH & Gender in Development, Disaster Management, Management of Rural Marketing and Cooperative Management.





4. Urban Field Work

The Institute's culture revolves around the learning through experiences, exposures, and realization of various situations. This is understood through the various experiences of students in their regular slum visits. It is a part of the Institute's tradition to deepen their experiences.

The first-year students of Rural Management have undertaken a Thematic Field Work in different batches in ten slum centres of Ranchi town. They devote two hours in the afternoon to the slum community. They facilitate the local community towards health, sanitation and hygienic practices. Practical Actions do contribute and help to improve the standard of living in the slums sustainably by focusing on the following key areas:

Improvement of reliable, safe and clean water access

- Improvement of sanitation
- The promotion of safe hygiene practices

Students regularly work with the slum communities with the following outcome:

- It involves everyone in the community.
- It stresses total elimination of open defecation using hygienic, locally constructed toilets.
- Collective community decision, collective local action, and local diversity and innovations are key elements.
- Interventions are decided locally and don't depend on external support.
- Natural leaders lead future collective initiatives.
- It ignites a change in sanitation and hygiene behavior rather than through simply constructing toilets.
- People decide together how they can create a clean hygienic environment.
- The community takes responsibility for its own actions.
- It advocates washing hands with soap or a substitute at least during four critical times.

Each group has undertaken a thematic study in a slum area of Ranchi town under Thematic Field Exposure Visits which include the following:

5. Institutional Visits

Two Institutional Visits of one day each for the 1st year students of Rural Management were conducted in two phases, 1st on 21st of July 2017 and the 2nd on 18th of August 2017 with the objective to get them exposed to the functioning of Voluntary / Social Development Organizations in and around Ranchi district. The exposure mainly covered learning about the Organizations' vision, mission, objectives, organizational structure, interventional areas, funding sources, and pattern and the challenges faced and the strategies adopted to overcome them. In the 1st phase, three visits for three separate groups of 25 students each were organized into three distinct organizations namely AROUSE Gumla, LEADS Khunti and PRADAN, Torpa. The similar system was followed in the 2nd phase of the visit. In this phase also another three organizations were visited namely AKSW Centre, Khunti, JSLPS, Nagri and ISSNIP, Khunti.

6. Rural Exposure (Village Camps)

The strength and character of the PGDM- Rural Management course is Rural Camps for its mode of interactions and outcome-based learning. During the academic year the Rural Camps were held for both 1st year and 2nd-year students in two separate time periods. Three camps for the 2nd year and the same number of camps for the 1st year were conducted wherein 25 students participated in each camp. The 1st exposure camp for the 1st year and 3rd Camp for the 2nd year of 10-day duration each were held from October 7th to 16th, 2017 whereas the 2nd camp for the 1st year and 4th camp for the 2nd year were held from 20th Feb to 1st March 2018. 7. Summer Internship Project (SIP)

Citing the academic practices and event's calendar of the RM department, students approaching the end of their 2nd year were sent to undertake SIP for a period of two months beginning from 20th April to 19th June 2017.

SIP mainly comprised of two aspects- firstly an Organizational Training (OT) for 15 days during which students were acquainted with the organization, their working techniques, and innovative functioning style, and secondly to increase engagement in the dissertation for the remaining period the students conducted their field studies based on the topics assigned to them by the respective organizations.

After the completion of both the aforesaid activities, the students submitted their interim report to the concerned organization and prepared their dissertation report upon their return to the Institute. All the reports of dissertation work were submitted to their respective guides for receiving feedbacks and instructions for improvement.

Finally the students finish their dissertations under the guidance of their respective supervisors. This entire experience of SIP beginning from the organizational visit to report preparation has been enriching for the students who have come across the working modules, ethics and functioning of the respective companies. The



students benefited from each learning exercise research material and the analytical skills including the ground reality of preparing the reports. These skills and hard work put up by the students help them to nurture the professional in them, with a clear concept of looking forward to working for the society. SIPs were carried out in various Corporate Organizations, NGOs, Government and the Semi-Government organizations. The SIP for the academic year 2017-18 was coordinated by Dr. Sant Kumar Prasad.

Money is the lifeblood of business and finance is the nerve center. Finance is required to promote or create a business, gain assets, develop products, run market surveys, and advertise. The goal of any finance function is to achieve three benefits: business support service, lowest costs, and effective control of the environment. The conventional view of finances focuses on being reactive, efficient, quantitative and risk averse. New innovative views focus on being vision-oriented, opportunity and growth focused, intuitive and risk-taking.

As Finance is required at each stage of an enterprise, i.e., promotion, incorporation, development, expansion and administration of day-to-day working, etc., proper administration of finance is very necessary. Proper financial administration means the study, analysis and evaluation of all financial problems to be faced by the management and to take proper decision with reference to the present circumstances in regard to the procurement and utilisation of funds. Hence, importance of finance cannot be over-emphasized. It is, indeed, the key to successful business operations. Without proper administration of finance, no business enterprise can reach its full potentials for growth and success.

The financial manger plays a very important role in the success of business organization by advising the top management the solutions of the various financial problems as experts. They assist the top management in its decision making process by suggesting the best possible alternative out of the various alternatives of the problem available.

The modern concept implies that finance is an integral part of the overall management rather than the mere mobilization of funds. The finance manager under this concept is expected to ensure a wise application of funds in the productive process of the organization. Thus, carrying out the financial activities of planning, raising, allocating and controlling of funds in the organization has become the important duty of a finance manager.

To cater to the changing requirement of the financial sector, the course of Post Graduate Diploma in Management - Finance is designed to prepare the best finance professionals in the country. This full time program provides necessary education for students



seeking finance positions in industry, in financial institutions, or in government or in non-profit organizations. It seeks to equip the students with conceptual and analytical skills for financial decision making and offers insights into how the financial markets function. Completion of this program provides students with theoretical & practical knowledge for successful attainment of management positions in the Insurance and the Banking sector. It also opens up avenue for financial analysts. The curriculum combines strengths in management with technical skills and internship opportunities in each area.

For this purpose, the Department is deeply concerned with the learning process which is based on study analysis, presentations, seminars, live projects, company internships, classroom lectures and discussions. The teaching pedagogy is purely case based problem analysis which helps students to understand the complexities of real life business.

The curriculum is very much flexible to ensure the current and foreseeable future requirements of the business. The activities of the Department of Finance during the year 2017-18 are as follows:

1. Freshers' Orientation Program

Every year the department has Freshers' Orientation Program for the new students. Departmental faculties, various corporate personnel and alumni of the Department took sessions in this year's orientation program for the incoming students for the batch of 2017-19 and explained them the importance of developing necessary skills and competence required for the corporate life. Mr. Amit Ranjan Sinha, GM-HR, Usha Martin Ltd., Ranchi took a session on "Strategies to Face Corporate Challenges" held in the month of June'17. Mr. Manish Thakur (Batch-2006-08), Business Head Jharkhand & Bihar, Mr. Ram Finance Ltd. & Mr. Amandeep Sahani (Batch-2008-10), Manager, HDFC Bank also talked about the challenges to be faced while working in an organization.

2. Rural Exposure Visit

The objective of rural visit is to study the rural market and the involvement of marketing and financial activities in rural areas. This year also the Department organised rural visits to Gumla and Simdega in the month of Feb.,2018 led by Mr. Bhaskar Bhowani & Dr. Rishi Dwivedi (Gumla) and Prof. Arana Kausar & Dr. Jay Prakash Verma (Simdega).

The group had a four days stay at **AROUSE** (Animation Rural Outreach Service), Gumla. On the very first day the students visited the Gumla JSLPS office and were briefed by the DPM Ms. Manisha Sancha and the her team about the dynamics and working of JSPLS with SHGs in the district. They also explained about the role of JSLPS



in implementing the development initiatives and schemes run by the Central and the State Governments.

The team visited villages, like Kasira Musatoli, Pandariya, Silam, Karonda Bera, Naratoli and Salyatoli where they met the SHGs and Mahila Samitis functioning in these villages and witnessed the development initiatives taken up by AROUSE, Gumla a Jesuit run NGO, **PRADAN** and JSLPS. The students were also able to get a glimpse of the tribal culture and history of Chotanagpur in a visit to the TRIBAL MUSEUM located in the campus of St. Ignatius School, Gumla. They also got an extensive exposure of the rural haats and explored their marketing dynamics.

Simdega Group (led by Prof. Arana Kausar & Dr. Jay Prakash Verma)

The group had a four-day stay at Simdega district in Jharkhand, during which they studied the rural economy

and the working of financial institutions at the village level. They visited villages in Thethaitangar block and interacted with the Executive members of the cluster level federation of Jharkhand State Livelihood Promotion Society, supported by NRLM (National Rural Livelihood Mission). They also visited Sansewai village and interacted with the Sarpanch and other members of the Panchayat and the members of the Self Help groups and the youth groups under the able guidance of the officers of Jharkhand Tribal Development Society. The understanding of livelihood projects successfully running in the villages definitely gave a deep insight for sustainable development. The students were deeply touched with the warm welcome they received by the villagers in the traditional ways. They also got an exposure of the village haats and the marketing dimensions. 18. Research Work & Publications

i. **Dr. Rishi Dwivedi**, Assistant Professor of Department of Finance has carried out research work in collaboration with Dr. Shankar Chakraborty, Professor of Production Management at Jadavpur University. He has developed a strategic decision making model for the footwear industry using activity based costing (ABC) and value chain analysis (VCA) models. In his research work, an integrated ABC-VCA model is proposed for the first time to comprehend the reasons for ineffectiveness in the chain and recognizes potential leverage points for enhancing the performance of the chain of a footwear enterprise. The research paper encompassing the said work has been accepted for publication in a Scopus indexed international journal titled *"Leather and Footwear Journal"*, Romania and will be published in upcoming September 2017 issue of the journal. The Leather and Footwear Journal is published by INCDTP - Division: Leather and Footwear Research Institute, Bucharest, Romania, at CERTEX Publishing House, which is acknowledged by CNCSIS (The National University Research Council).

ii. Dr. Rishi Dwivedi, Assistant Professor of the Department of Finance has also developed a performance measurement tool for an agricultural enterprise using balanced scorecard (BSC) and quality function deployment (QFD) models in association with Dr. Shankar Chakraboty, Professor, Jadavpur University, Mr Amresh Kumar, Assistant Professor, Sikkim Manipal Institute of Technology, Ms. Snigdha Singh (Fin-2016-18), XISS, Ranchi and Ms. Richa, (Fin-2016-18), XISS, Ranchi. This research work proposes the application of BSC model in an Indian seed manufacturing organisation to place the organizations expediently against the competitors by aligning its corporate vision and strategy with organisational performance through the interconnectedness of different layers of perspectives. Next, a framework to integrate both BSC and QFD models is provided for the first time in a seed manufacturing industry in order to evaluate its performance over the two time periods. The integrated BSC-QFD technique can help managers to understand competitive strength of the said organization and in turn facilitate in efficient and effective decision making. The paper constituting this research work has been accepted for publication in the Proceedings of the 1st International Conference on Mechanical, Materials and Renewable Energy, which was held in Majitar, Sikkim, from December 8 to 10, 2017. The proceedings of the said conference have been published by IOP Conference Series: Materials Science and Engineering, which is indexed in globally renowned indexes such as, Conference Proceedings Citation Index – Science (CPCI-S) (Thomson Reuters, Web of Science), Compendex, Scopus, Inspec, Chemical Abstracts Service, INIS (International Nuclear Information System), NASA Astrophysics Data System, SPIRES, VINITI Abstracts Journal (Referativnyi Zhurnal).

iii. Dr. Amit K. Giri published an article entitled, "India's Economy Post Demonetization: A Preliminary

Assessment", in the *Jharkhand Journal of Development and Management Studies, Vol. 15,* No. 2, (April-June, 2017).

iv. **Rev. Fr. Pradeep Kerketta, S.J.**, Assistant Director, XISS and Dr. Amit K. Giri have voluntarily taken up a project to study the working conditions of daily wage earners in Ranchi city, Jharkhand. On the invitation of the Indian Society of Labour Economics (ISLE), the findings of the study was presented in the form a research paper entitled "Working Conditions of Daily Wage Labourers in Ranchi, Jharkhand" in the *59th ISLE Conference*, which was held in Trivandrum, Kerala, during16-18 December, 2017.

Placement Report Batch 2016-18

The Placement Team at XISS, Ranchi is pleased to announce another successful completion of the final placements for the PGDM batch of 2016-18. The team would like to express sincere thanks to everyone involved in the smooth coordination of placements. This collective effort has resulted in rewarding results for students at a crucial juncture in their careers and lives.

This year final placement has achieved a new milestone by getting 06 Pre-Placement Offers and the highest package of Rs. 13.50 lakhs per annum. There is a substantial improvement in Summer Internship wherein most of the students are having paid internships and also in reputed organisations. Although, the shrinking job opportunities is making the task very challenging.

We would like to thank our regular recruiters who continued their strong relationship with us and offered placements across different Departments. We are also grateful to the new recruiters who visited our Institute and recruited our students as a show of trust in XISS and the students.

The Team XISS has taken various initiatives to make this process successful, namely, mentoring by faculty members, documentation of feedback from seniors, mock interview and GDs, timely preparation of Placement Brochure, understanding the need of various sectors and managing the relationship with the corporate etc. A new initiative from this year was to empower our students' placements representatives for mailing and contacting the corporate for placements. This has helped in greater reach to corporate and the alumni.

Key Highlights

- Highest Package this year is Rs. 13.50 Lakhs per annum.
- 6 PPOs from three departments i.e. HRM, Marketing and Rural Management
- Overall 83.1% of students placed.
- Percentage placed in 1st Phase was 56.4%
- Most of the Summer Internships for Batch 2017-19 are with Stipend & PPO facility (Highest Stipend = Rs.75000.00 per month).





Although the job market is very competitive, XISS was successful in getting the participation of some 80+ companies in the final placement process out of which 32 percent were new recruiters. The number of offers made was 236 with a highest salary of Rs. 13.50 lakh/annum and the average salary package of Rs. 5.87 lakh/ annum. The average salary for HR department has reached to Rs. 7.81 lakh/annum. The Department of Finance Management, the Department of Rural Management, and the Department of Marketing have achieved a placement of 96.2%, 95.8% and 94.2% respectively. We expect few more offers as the recruitment processes of a couple of organisations are still in process.

The recruiters participated were from different sectors such as Consultancy, Manufacturing, Logistics, FMCG, IT, Telecom, Retail, Social/Non-Profit Organisations, Banking, Financial Services & Insurance (BFSI), etc. The major recruiters (organisations) were from BFSI (25%), Manufacturing (22%), Development Sectors (17%) and Technologies (10%).

The highest numbers of job offers were in the sector of BFSI i.e. 38% of total students placed, followed by Development Sector (19%) and Manufacturing Sector (17%).




2. Primary objectives and planning

The Institute's library has a special section known as **"Kumar Suresh Singh Reference Collection"** donated by **Mrs. Bimleshwari Singh**. This is the personal collection of **4000 books** of **Late Kumar Suresh Singh** an IAS officer and Director- General of the Anthropological Survey of India.

3. Resources

DEVELOPMENT RESOURCE CENTRE

1. Introduction

Development Resource Centre (DRC) was established in 1989 to promote voluntarism and strengthen social action in the Jharkhand region among the small voluntary organisations through capacity building interventions, information sharing and networking, clustering initiatives and resource linkage building with secular spirit and giving an equal opportunity in the promotion of voluntarism. DRC has supported the efforts of small organizations working at the grass root level through capacity building process and has created a pool of likeminded organizations/institutions/ individuals/community leaders/youth group/farmers to understand the present needs of the society and act accordingly.

Since its inception development efforts in delivering services to meet the emerging training needs and professional support to grassroots level action groups and NGOs, DRC has emerged as one of its kind of development support centers in Jharkhand. The development priorities of DRC was more sharpened from 1997 onwards on tribal empowerment and its interventions were focused on self-help group development as a potential platform for enhancing the socio-economic status as well as securing sociopolitical identity of the people.

2. DRC Projects during the year 2017-18

During the year 2017-18 DRC implemented the following two projects:

(i) Enhancement of Livelihood Opportunities in the selected Blocks of the south eastern region of Chotanagpur in the state of Jharkhand. The project is being supported by CONFERENZA EPISCOPALE ITALIANA.

(ii) India Development Gateway Initiatives (InDG): Vikaspedia project supported by the Department of Electronics and Information Technology (DIETY), under Ministry of Communications and Information Technology. The project is monitored by C-DAC, Hyderabad.

(i). Enhancement of Livelihood Opportunities in the Selected Blocks of the South Eastern Region of Chotanagpur in the State of Jharkhand





During the reporting period 2017-18 in its extension year DRC, XISS while capacitating the initiative looked forward to the completion of its major objective of "Enhancement of livelihood opportunities in the Selected Blocks of the south eastern region of Chotanagpur in the state of Jharkhand' in the far off remote and rural pockets of the Southern Chotanagpur region of Jharkhand, India to combat the prevailing poverty concerns working along with 11 Voluntary Organizations.

The project is in the process of building the capacity of VOs and CBOs, through SHG meetings even during this extension phase to strengthen the women's groups and making the target groups to reach more towards their goal of income generating activities. Various project activities have unfolded so as to develop a region-based women's forum through bringing together a cluster group of 8-12 women for a wide coverage and reach of the project. DRC therefore, undertook a series of activities for creation of such cluster formation for all staffs of VOs and CBOs and provided them with training cum workshops on cluster formation. Simultaneously, the VOs and CBOs have enabled the SHG representatives through intense Cluster Formation at the field level.

From its initiation level, the project has focused on the Empowerment of SHGs/women groups and strengthening of Income Generating activities both through backward and forward support in line of convergence with the Government line departments to mobilize and provide the required financial support for IGAs and promoting SHG clusters and federation.

DRC with the help of 11-CBOs and VOs achieved significant results involving 50% (1377) target groups out of 2741 in Income Generating Activities. The major involvements of target groups in Income Generating Activities (IGAs) are poultry farming, vegetable cultivation, lac cultivation, piggery, goatry and small shops in rural area.

On- Site Training on Vegetable Cultivation

Several on site trainings on vegetable cultivation were organized at the locations of CBOs and VOs. The details of the training are provided in the following table no 1.

So far the Department has conducted more than three hundred and twenty (320) Entrepreneurship Development Programs (EDPs), skill development programs and related programs sponsored by the apex funding agencies.

The prime focus of the Department is to provide Entrepreneurship education, skill training and micro-finance development with activities like, organizing different categories of Entrepreneurship Development Programs, providing skill training in different trades, organize awareness camps on entrepreneurship, conduct Faculty Development programs or Trainers' Training programs on entrepreneurship and short term Management Development Programs.

The results we have achieved is very encouraging and our training has yielded significant success. Our trainings have helped the participants to improve their self-esteem, confidence, social status, and economic empowerment.

1. What is CHILDLINE?

CHILDLINE stands for a friendly 'didi' or a sympathetic 'bhaiya' who is always there for vulnerable children 24 hours of the day, 365 days of the year.

A phone number that spells hope for millions of children across India, CHILDLINE is India's first 24-hour, free, emergency phone service for children in need of aid and assistance. Whether you are a concerned adult or a child, you can dial 1098, the toll free number to access our services. We not only respond to the emergency needs of children like medical aid, repatriation, rescue, emotional support and guidance, etc. but also link them to services for their long-term care and rehabilitation in the space of shelter.



CHILDLINE is a platform for bringing together the Ministry

of Women and Child Development (MWCD), Government of India, Department of Telecommunications, street and community youth, non-profit organisations, academic institutions, the corporate sector and concerned individuals. CHILDLINE scheme across India is supported by the Union Ministry of Women and Child Development (MWCD) and facilitated by Childline India Foundation (CIF), Mumbai under the Integrated Child Protection Scheme (ICPS).

Childline India Foundation (CIF), Mumbai is the nodal organization for CHILDLINE service across the country. The goal of CIF is to reach out to marginalized children in need of care and protection.

2. Target Audience

We work for the protection of the rights of all children in general. But our special focus is on all children in need of care and protection, especially the more vulnerable sections, which include:

- Street children and youth living alone on the streets
- Domestic help, especially girl domestics
- Children affected by physical / sexual / emotional abuse in family, schools or institutions
- Children who need emotional support and guidance
- Victims of child trafficking
- Children abandoned by parents or guardians
- Missing children
- Run away children
- Children who are victims of substance abuse

- Differently-abled children
- Children in conflict with the law
- Children in institutions
- Mentally challenged children
- HIV/ AIDS infected children
- Children affected by conflict and disaster
- Children whose families are in crises

3. Structure of CHILDLINE at the city level

Every city, where the CHILDLINE service is running, has a similar structure, as well as a uniform process in which it assesses the needs of the children, develops a resource directory of organizations in the city and ensures that the phones are ringing and provides training to the new team. CHILDLINE functions through a network of NGOs, academic institutions, the corporate sector and the allied systems. The key stakeholders in the CHILDLINE model at each city/district are:

- CHILDLINE Advisory Board (CAB): CAB comprises senior level functionaries from the allied system, NGOs, concerned individuals, media etc. The CAB reviews information received by local CHILDLINE's from children collated at Open House sessions. The CAB ensures that all Allied systems' stake-holders and organisations are actively involved in Child Protection in their cities.
- The Nodal Organisation is mostly an academic institution which ensures coordination, training, research, documentation, awareness and advocacy.
- The Collaborative Organisation is the 24-hour service for children, which responds to the intervention cases, provides emergency intervention if required, links the children to the services for ultimate rehabilitation, conducts awareness and outreach programmes and documents every case that comes into CHILDLINE including the intervention or follow-up done.
- The Support Organisation responds to calls referred by the collaborative organisations and conducts awareness and outreach programmes.
- The Resource Organisations act as referral centres for CHILDLINE. They also participate in outreach and awareness programmes for CHILDLINE.
- The CHILDLINE Contact Centre (CCC) is the centralized call centre initiative of CIF. There are six CCCs located in Mumbai (2), Kolkata (1), Chennai (1), Bangalore (1) and Gurgaon (1); and they receive calls to 1098 from all cities. Intervention calls are forwarded to partners.
- CHILDLINE has thus evolved into partnership between children, the Government, NGOs, academic
 organizations and the community at the city and national levels to respond to the concerns of marginalized
 group of children.

CHILDLINE's comprehensive strategy to bring about systematic change by creating child friendly systems has yielded astonishing results. CHILDLINE works with the system and its processes on behalf of the child to reach the goal of a safe child friendly environment.



4. CHILDLINE 1098 – How it works

The intervention methodology

CHILDLINE Contact Centre (CCC) is a modern facility using contemporary BPO technology. Hence a 1098 call landing at CCC is immediately transferred by a "Switch"/Server to an agent Childline Contact Officer (CCO). The Call is linked to a server that records the call as well as to a CRM (Customer Relations Management software) server. The CRM server then pops/opens a screen for the scripts. Once the conversation is done and the CCO decides that this is an intervention call requiring direct intervention, the CCO dials an out bound call to the IU (Intervention Unit) in the city (of the caller) and informs the CHILDLINE team to determine the nature of interventions done and status of the case. The CRM server collates the details of all such cases received directly by the local team either at their office or during outreach activities. Thus in this model the voice domain of CHILDLINE (response to calls) are handled by CCC and the direct intervention is handled by the IU (Intervention Unit – local CHILDLINE Collaborative partner).



5. Childline intervention at city level

A phone number spells hope for millions of children. Any call coming into a CHILDLINE centre is attended to by the CHILDLINE teams. This ensures that the calls coming in are attended to, all 24 hours at the phone-receiving centre. Depending on the nature of the call, be it by a child or an adult, the team member responds to it effectively. The intervention could be by going to meet with the child first and then linking him or her to medical help, shelter, repatriation, rescue from abuse or even intensive counseling as per requirement.

At CHILDLINE we believe that every call is important

Child or adult, each call at 1098 is important and taken seriously.

We Respond » Children are especially vulnerable to crisis situations where they are trapped with no one to



respond to their pleas for help. Our primary function is to respond to the needs to such children, more so in emergencies. We define emergency as a crisis period in the child's life, wherein if the child does not get timely and sustained intervention, it could lead to the relapse of child into the crisis situation. After the emergency need is taken care of, we also help the child with rehabilitation.

We Sensitize » An important function of CHILDLINE is to sensitise, train and collaborate with allied systems, such as the Police, Hospital, Railway, Municipal Corporations, Government, Educational Institutions and Social Welfare Organisations to work towards ensuring the rights of children in need of special care and protection.

We Document » In order to increase transparency and accountability, we always document the process of CHILDLINE. We also conduct research on relevant issues to bring them to the fore and to help this to make a child friendly world.

We Build » We are dedicated to working towards building a referral network of legal, medical, economic and media professionals to advocate for child related issues.

We Network » It is important to bring every child into the fold of child protection organizations. To increase our outreach, we work to establish CHILDLINE networks in the region.

We Involve » We involve the government, the public, the media and the corporate sector in our efforts to respond to children's needs.

We Advocate » Since it is important to create a legal framework to support any issue, we advocate for changes in laws and policies relating to children's issues.

We Explore » We believe that integrated, synergised efforts can go a long way in enabling us to create a widespread network of outreach for children.

CHILDLINE explores options with the child to study, learn a trade, go back home, etc. Based on the decision of the child, CHILDLINE links the child to an appropriate organisation in the city.

If the team member feels that some time will be involved in reaching out to the child in terms of physical distance, then assistance from a support organisation located in the vicinity of the caller is sought. After the emergency intervention measures are taken by the CHILDLINE, the next step is to link the child with long-term rehabilitation. This involves referral and networking with other organisations providing specialised services.

In this process - from Response to Rehabilitation, the children's participation is an integral component. The country's first toll-free tele-helpline for street children has grown into a national child protection service that operates in over 420 cities and towns in India.

6. CHILDLINE – 1098 Service in Jharkhand

CHILDLINE-1098 started ringing in Jharkhand in 2001 in the city of Ranchi. Gradually, it expanded its services to the Districts of Dhanbad, Pakur, Chaibasa, Deoghar, Hazaribag, Palamu, East Singhbhum, Giridih, Koderma and Khunti. Additionally a CHILDLINE unit is operational in Ranchi Railway Station from June 2015.

The CHILDLINE-1098 service started in Jharkhand initially with thesupport from the Ministry of Social Justice and Empowerment, Government of India. Later on, it came under the purview of the Ministry of Women and Child Development, Government of India in 2006. Presently, the CHILDLINE – 1098 service is operational in 13 cities / districts in Jharkhand namely – Ranchi, Dhanbad, Pakur, Deoghar, Chaibasa, Giridih, Gumla, Hazaribagh, Khunti, Koderma, Palamu, Sahibganj, and East Singhbhum

The CHILDLINE Urban model is operational in Ranchi and Chaibasa whereas rural model is operational in







Dhanbad, Deoghar, Pakur, Giridih, Gumla, Hazaribagh, Khunti, Koderma, Palamu, Sahibganj, and East Singhbhum

CHILDLINE India Foundation (CIF) envisages extending its service to 4 more Districts, Garhwa, Lohardaga, Bokaro, and Simdega. The plan for approval was submitted by CIF to the Ministry of Women and Child Development, Government of India.

7. Childline case intervention

CHILDLINE-1098 service in Jharkhand has intervened in 1998 cases. CHILDLINE has effectively provided services of medical, shelter, restoration, rescue from abuse, and sponsorship. The following graph provides a break-up of CHILDLINE case intervention during the period from April 2017 till September 2017 of all thirteen districts of Jharkhand.

Types of cases intervened by CHILDLINE




Figure 1: Type of cases intervened by CHILDLINE

Out of the total number of 1998 cases intervened by CHILDLINE, 468 cases were of protection from abuse; in 333 cases children have been restored back to their families; in 223 cases support was provided for medical treatment; in 224 cases shelter has been provided; in 116 cases parents/guardians were linked with police for lodging missing FIR; in 42 cases emotional support and guidance were provided; sponsorship support was given to 56 children; 1 case was related to child in conflict with law; and finally, in 415 cases long term support or linkages with government schemes were provided.

8. District wise break up of case intervention

During the period April 2017 to September 2017, CHILDLINE at Jharkhand has intervened a total number of 1998 cases. Out of the total number of cases, CHILDLINE Ranchi has intervened the highest number of cases (376), followed by Dhanbad (246), Pakur (194), Sahibganj (185), East Singbhum (184), Hazaribag (173), Deoghar (153), Gumla (116), Chaibasa (111), Koderma (107), Giridih (62), and Palamu (56). The least number of cases were intervened from Khunti (35).




Figure 2: District-wise total number of cases

9. CHILDLINE Ranchi

It is an urban model of 1098 service and is delivering the service through three partner organizations in the Ranchi district.

Additionally a CHILDLINE unit is operational in Ranchi Railway Station from June 2015, coordinated by Brother Maju Mathew. The CHILDLINE Unit at Ranchi Railway Station has also extensively conducted outreach programmes in and around Ranchi Railway Station and held multistakeholders' meeting with vendors, shop owners, cleaners and collies working in the station.

10. Open House Programme

Children are also involved in evaluating the CHILDLINE service through Open House Programmes. It is a platform for children to express their opinions, give suggestions, address conflicts and give feed backs. Open House serves as a forum for children to assess, review and evaluate CHILDLINE functioning. This open uninhibited interaction that allows CHILDLINE team along with the children to identify solutions to problems, thereby giving children the authority to judge a situation and decide a verdict or determine a course of action in relation to a problem. It also serves as an opportunity to share the positive encounters between children and functionaries of allied systems like the police, health personnel, etc, who otherwise traditionally share a relationship of mistrust. This helps not only in giving insights for improving the services but also in building a relationship of trust with the children.

In the financial year 2017-18, CHILDLINE Ranchi has conducted 24 Open House Programmes. CHILDLINE has also ensured participation of Principals, School teachers, Students, Ward members, SHG members and other stake holders in these programmes through formal invitation.

The issues raised by children in Open House are:

- Substance abuse
- School drop-outs
- Child marriage
- Child labour
- Sexual abuse
- Incidence of eve-teasing
- Problem of drinking water and sanitation in schools

CHILDLINE team culls out the issues raised by children in open house programmes and escalates the same to the concerned authority towards resolving the issues. Follow-up visits are also done and the children are informed on the steps taken by CHILDLINE team towards resolving their problem.

11. Out-reach and awareness

In CHILDLINE, the principle of outreach and awareness programmes is to reach out to the children, concerned adults, allied system, corporates and thereby the community at large and to ensure awareness on CHILDLINE 1098 across the operational area. Besides school visit, meeting with stakeholders like AWW, SHG members, Rural Police, Gram Panchayat, Health Workers, etc., the team has conducted awareness programmes with the VLCPC and BLCPC members and allied system in respective areas of Ranchi city.

CHILDLINE team has conducted a total number of 4627 person hours of outreach and awareness programmes in the financial year 2017-18. Out of 469 cases, 207 cases have been received from outreach and awareness programme.

CHILDLINE Se Dosti is a week-long campaign organised from 14th – 20th November, 2017 to make ordinary citizens stakeholders in CHILDLINE 1098. The primary objective of this campaign is to spread awareness amongst those who remain unaware about the work done by CHILDLINE and generate CHILDLINE 'Dosts' everywhere.

Be it an allied system, a student, an auto driver, a rickshaw puller or a housewife, it is our objective to reach out to people from different walks of life to get to know CHILDLINE, begin to care about vulnerable children and initiate action towards change. The ostensible purpose of this campaign is to generate a Million 'Dosts' for CHILDLINE and acquaint people with Child Rights and Protection.

Following are the activities organized for smooth functioning of CHILDLINE, Ranchi.

- In-House Training Programme: In-house training is for capacity building and learning opportunities for Coordinators, Team members and Volunteers of CHILDLINE team. This in-house training programme was organized on 18th and 19th December, 2017 in Conference hall of XISS. Training was mainly on Juvenile Justice Act, 2015 and JJ Rules, 2017, Practical issues in dealing with children who need care and protection, GD/FIR and other aspects of children, POCSO (Protection of Children from Sexual Offence) Act, 2012 and Documentation and motivational learning.
- Agreement between XISS and CIF (Childline India Foundation) was again signed on 4th July, 2017 for another three years.
- Grant of previous financial year 2016-17 was sanctioned vide letter no. BG/E/16-17/26 dated: 13th November, 2017.
- We as a nodal oraganisation of Childline, coordinate activities like advocacy and networking with allied system like, Police, Health Dept., Education Dept., Railway Dept., Labour Dept., Ranchi Municipal Corporation, Juvenile Justice Board, Child Welfare Committee, etc. and provide necessary support to intervention unit and support organization for case interventions.

- City Advisory Board (CAB) chaired by Deputy Commissioner, Ranchi was organized in Conference Hall of Deputy Commissioner, Ranchi on 17th March, 2017 and Resource organizations meet was also organized in third week of March, 2018.
- Number of cases of children reported in the Intervention Unit during April, 2017 till 30th November, 2017 is 469. Category-wise, the cases are given below in the table 2.




Figure 3: Category-wise case intervention

Numerous shelter homes exist in our country and in these shelter homes there reside quite a good number of children who are longing to go back to their homes and families but cannot do so because of lack of information about their parents and addresses. In such type of cases, CHILDLINE helps the children to recognize their address or some clue to get to their birth guardians through in-depth counseling.

CHILDLINE becomes fruitful in securing the children's future

One day, a coordinator accompanied by a counselor of CHILDLINE Delhi visited the Shelter Home to see the children over there. They got to meet a 8 year old boy named Raju over there. When they had a brief conversation with him, they came to know that he really wanted to go back to his home and also knew his father's name (Birsa). Then the counselor counseled the child, and during the session he told that he belonged to Latehar, Jharkhand. Then the team member of CHILDLINE Delhi went to Child Welfare Committee (CWC) and took the order to refer the case to CHILDLINE Ranchi to trace out the address of the child. After taking the order from the CWC CHILDLINE Delhi team member contacted CHILDLINE Ranchi to trace his address. After almost a week, CHILDLINE Ranchi sent a mail to CHILDLINE Delhi in which it was mentioned that they have found the child's address which is in Latehar, Jharkhand. Immediately CHILDLINE Ranchi team members on the order of the CWC personally went to the child's home at the found address. Thereafter they completed all the required legal formalities and finally handed over the child to his family.

In this way CHILDLINE restored the child to his family and became fruitful in securing the child's future.

Way Forward....

CHILDLINE has thus evolved into a partnership between children, the Government, NGOs, academic organizations and the community, at the city and national levels, to respond to the concerns of marginalized groups of children. CHILDLINE's comprehensive strategy to bring about systemic change by creating child friendly environment has yielded astonishing results. CHILDLINE works with the system and its processes on behalf of the child to reach the goal of a safe child friendly environment. Hence, impact and change are processes that take a considerable amount of time and call for perseverance. It is the surest way to ensure a long-term solution.
